NOTICE OF OPPORTUNITY FOR PUBLIC COMMENTS AND BOARD CONSIDERATION OF PROPOSED ORDER SETTING ASIDE WATER QUALITY CERTIFICATION FOR THE YUBA RIVER DEVELOPMENT PROJECT

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept written comments on a <u>proposed order</u> setting aside the water quality certification (certification) for the relicensing of Yuba County Water Agency's Yuba River Development Project, Federal Energy Regulatory Commission Project No. 2246. The proposed order would set aside this certification and dismiss the pending petitions for reconsideration of this certification.

Written comments must be submitted no later than **12:00 noon on Friday**, **August 9, 2024**. Written comments must be submitted per the procedures in the "Submission of Written Comments" section of this notice.

NOTICE IS ADDITIONALLY HEREBY GIVEN THAT the State Water Board will consider adoption of the proposed order on **Wednesday**, **September 18, 2024** at the State Water Board meeting. The anticipated date, time, and location of the State Water Board meeting are provided below:

BACKGROUND

As discussed in section IV of State Water Board Order WQ 2024-0046, in September 2023, the United States Environmental Protection Agency (USEPA) promulgated the Clean Water Act Section 401 Water Quality Certification Improvement Rule (2023 Rule). In the preamble accompanying the 2023 Rule, USEPA provided, for the first time, an interpretation of section 401 of the federal Clean Water Act (Section 401) that precludes certifying authorities such as the State Water Board from issuing a certification in the absence of a currently pending request for certification. In light of USEPA's new interpretation, the proposed order sets aside the 2020 Yuba River Development Project certification that was issued by the State Water Board's Executive Director without a pending request for certification, where the State Water Board had previously received a request for certification that had been denied or withdrawn, and Yuba County Water Agency was still actively pursuing a federal hydropower license. As discussed in State Water Board Order WQ 2024-0046, although the State Water Board believes its issuance of this certification was proper and its interpretation of Section 401 remains reasonable, the State Water Board defers to USEPA's new interpretation. If this certification is set aside by the proposed order, there would no longer be any action of the State Water Board to be reconsidered. Therefore, to avoid the unnecessary expenditure of resources, the proposed order also dismisses the petitions for reconsideration of the certification.

EX PARTE DISCLOSURE REQUIREMENTS

Reconsideration of the certification is subject to the prohibition on ex parte communications, as described in a <u>Memo from the State Water Board's Office of the Chief Counsel</u> (http://www.waterboards.ca.gov/laws_regulations/docs/exparte.pdf). In general, communications about certain pending matters, such as reconsideration of the certification, in the absence of other parties and without notice and opportunity for all parties to participate in the communication are prohibited.

Any communications regarding reconsideration of the certification (except for non-controversial procedural matters) must occur at a publicly noticed meeting or workshop, or be submitted to the Clerk to the Board in writing.

PROCEDURAL MATTERS

At the September 18, 2024 State Water Board meeting, the State Water Board will consider adoption of the proposed order. Participants will be given the opportunity to speak to the State Water Board directly and to summarize and supplement their written materials with oral information during the State Water Board meeting. There will be no sworn testimony or cross examination of participants. However, the State Water Board and its staff may ask clarifying questions. To ensure a productive and efficient State Water Board meeting, the State Water Board may limit the time for oral comments.
