6. Report by State Water Resources Control Board Liaison [Sean Maguire, 916/341-5877]

State Water Resources Control Board Member Sean Maguire provided a brief update on funding expenditure plans for the Clean Water State Revolving Fund program that issues grants and loans for wastewater and recycled water type projects, the Drinking Water State Revolving Fund for drinking water projects, and Safe and Affordable Funding for Equity and Resilience (SAFER) program for disadvantaged communities to address critical drinking water issues.

State Board member Maguire discussed the challenges with the State budget resulting in recycled water grant program to reduce funding. Some funding was restored once the current budget was adopted.

Proposition 4 on November ballot could provide funding for State Board to administer loans and grants for water quality, safe drinking water, water reuse, and multi benefit stormwater projects. State Board member Maguire indicated that the State Board is in the process of updating the Small Municipal Separate Storm Sewer System (MS4) permit. State Board released a draft for a 60-day informal public comment period on August 1, 2024. Changes include inclusion of statewide Trash Policy, cost reporting requirements, and alternative compliance approach opportunities.

Member Hunter asked for additional information about SAFER funding. State Board member Maguire indicated that SAFER is at year 5 out of 10 years of funding for \$130 million per year.

Vice Chair Wolff asked about water conservation goals for municipalities and what the state is doing in terms of monitoring to determine if those goals are being achieved. State Board member Maguire responded that there are regulations now in place to establish water budgets and reporting is required for systems with more than 3,000 connections.

Chair Gray asked what State Board's position/direction regarding PFAS. State Board member Maguire said there continues to be a focus on determining health information and where the PFAS is located and that he will check with his staff to provide further update at a future meeting. There is some funding that has been afforded to underrepresented communities to sample drinking water for PFAS (about 4,000 wells sampled through this grant funding). Chair Gray asked about the status of the wastewater needs assessment. State Board member Maguire indicated that they are still evaluating information and preparing the assessment.

- 8. Stormwater Program Update

[Leah Lemoine, Senior Water Resource Control Engineer]

Stormwater program manager Leah Lemoine provided a program update that included an overview of federal stormwater regulations; summaries of the permits used to regulate stormwater discharges from municipal, industrial, and construction sources; a discussion of program priorities; a summary of the Central Coast Post-Construction Requirements (PCRs) and their implementation; and, finally, a look at how the program is incorporating considerations related to climate change and extreme weather patterns into permit implementation. Amanda Magee from the State Water Board's Strategy to Optimize Resource Management of Stormwater (STORMS) program shared information about their work to facilitate large-scale stormwater capture and reuse through investigative reports, development of guidance documents, and evaluation of quantification methods for stormwater capture. 9. National Pollutant discharge Elimination System (NPDES) Program Update [Arwen Wyatt-Mair, Senior Water Resource Control Engineer, 805/542-4695]

NPDES program manager Arwen Wyatt-Mair provided a brief overview of the NPDES program, including its history, governing regulations, permitted facilities, and implementation and enforcement activities of program staff. Board members asked questions about various topics including climate change planning, back-up power, permit fees, technical assistance, and the status of certain facilities.

13. Land Disposal Program Update

[Martin Fletcher, Water Resource Control Engineer, 805/549-3694]

Land disposal program staff Martin Fletcher provided a land disposal program update that included a summary of land disposal program staffing, facilities permitted, applicable state and federal regulations, water quality concerns, regulatory tools, landfill design requirements, and composting regulatory requirements. In addition, the update provided information on the land disposal program's annual priorities and goals prioritized around protecting water quality, outlined recent and anticipated future efforts to monitor for and evaluate PFAS at our landfills. The program update also emphasized that the land disposal program actions incorporate Water Board priorities focused on protecting drinking water, outreach to underrepresented communities, and climate change. Water Board members discussed the information presented and added comments and questions on statewide and local recycling efforts, and potential for future facilities and closure of existing facilities.

14. Consideration of Proposed Order R3-2024-0036, General Waste Discharge Requirements for Closed Landfill Facilities in the Central Coast Region [Nicholas Smaira, Engineering Geologist, 805/549-3467]

Land Disposal Program staff Nicholas Smaira provided an overview of proposed Order R3-2024-0036, General Waste Discharge Requirements for Closed Landfill Facilities in the Central Coast Region (proposed general order) and discussed postclosure maintenance activities, regulatory improvements compared to previous individuals waste discharge requirements, and the addition of per and polyfluoroalkyl substances (PFAS) to the monitoring and reporting requirements. Additionally, staff summarized the public outreach process and discussed that the public comments received were primarily related to concerns about the costs associated with the proposed PFAS monitoring and reporting requirements. Board Members discussed the proposed general order, existing groundwater impacts and corrective actions programs at closed landfills, the proposed PFAS monitoring requirements and the statewide PFAS monitoring efforts. Board Members agreed that the proposed PFAS monitoring and reporting requirements are necessary and reasonable to ensure the protection of human health, water quality, and beneficial uses.

Public Comment: Carolyn Burke, Assistant Public Works Director for the County of Santa Cruz in the Special Services Division, provided comments on the PFAS monitoring requirements of the proposed general order and urged the Board to postpone PFAS monitoring at closed landfills until a broader statewide approach is developed.

Motion: Vice Chair Wolff moved to adopt Order R3-2024-0036 General Waste Discharge Requirements for Closed Landfill Facilities in the Central Coast Region

then amended the motion to incorporate the edits identified in the Supplemental Sheet.
