NOTICE OF OPPORTUNITY TO COMMENT

PROPOSED APPROVAL OF AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE SANTA ANA RIVER BASIN TO INCORPORATE TOTAL MAXIMUM DAILY LOADS FOR SELENIUM IN FRESHWATER: NEWPORT BAY WATERSHED, ORANGE COUNTY, CALIFORNIA

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of the Santa Ana Region Water Quality Control Board's (Santa Ana Water Board) amendment to the Water Quality Control Plan for the Santa Ana River Basin (Basin Plan) that would incorporate Total Maximum Daily Loads for Selenium in Freshwater, Newport Bay Watershed, Orange County, California (Basin Plan amendment). The Basin Plan amendment was adopted by the Santa Ana Water Board on August 4, 2017 (Resolution No. R8-2017-0014) and is available for review at: https://www.waterboards.ca.gov/santaana/water_issues/programs/tmdl/docs/Se/R8-2017-0014.pdf.

Oral comments at the State Water Board meeting generally will be limited to a summary of the written comments submitted during the written comment period. Persons interested (including those who submit oral or written comments to the Santa Ana Water Board and State Water Board) in receiving notice of the meeting at which the State Water Board will consider approving the Basin Plan amendment **must subscribe** to https://www.waterboards.ca.gov/resources/email_subscriptions/reg8_subscribe.html by checking the boxes for Basin Planning and TMDL Orange County. Comment letters must be received by 12:00 noon on Friday, September 7, 2018. Comment letters received after that deadline will not be accepted unless the State Water Board determines otherwise. REQUIREMENTS FOR SUBMITTING COMMENTS (23 Cal. Code Regs., § 3779, subd. (f)). The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

- 1. Comments must specifically address the final version of the Basin Plan amendment adopted by the Santa Ana Water Board.
- If the Santa Ana Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Santa Ana Water Board to each comment was inadequate or incorrect.
- 3. The commenter also must include either a statement that each of the comments was timely raised before the Santa Ana Water Board, or an explanation of why the commenter was unable to raise the specific comment before the Santa Ana Water Board.
