NOTICE OF PUBLIC HEARING

ONSITE WASTEWATER TREATMENT SYSTEM POLICY CONDITIONAL WAIVER RENEWAL AND TMDL LIST AMENDMENT

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will hold a public hearing to receive comments on the Onsite Wastewater Treatment System (OWTS) Policy conditional waiver renewal and TMDL list amendment. Proposed changes include:

- 1. Renew the conditional waiver in the OWTS Policy. By law, waivers expire five years after adoption; the conditional waiver in the OWTS Policy will expire on May 13, 2018. The renewal will keep the waiver in effect.
- 2. Amendments to Tables 5 and 6 in the OWTS Policy Attachment 2. The tables provide a list of impaired water bodies and a schedule for total maximum daily load (TMDL) adoptions. Amendments are based on completed work or new information available regarding OWTS contributions to surface waters.

The State Water Board may adopt the OWTS Policy conditional waiver renewal and TMDL list amendment at the end of the hearing. The location and time of the public hearing is provided below.

BACKGROUND

Conditional Waiver Renewal

The State Water Board adopted the OWTS Policy on June 19, 2012; it was approved by the Office of Administrative Law on November 13, 2013; and consistent with OWTS Policy section 13.0, became effective six months later on May 13, 2013. The conditional waiver was issued pursuant to Water Code section 13269 and is contained in OWTS Policy section 12. The conditional waiver waives the requirement for owners of OWTS to submit a report of waste discharge (RWD), obtain waste discharge requirements (WDRs), and pay fees for discharges from OWTS that are covered by the Policy. The conditions include requirements that the OWTS operates properly, not cause a condition of nuisance or pollution, comply with all applicable local requirements, and comply with TMDL implementation requirements, among other conditions.

OWTS Policy Attachment 2 contains Tables 5 and 6. The tables provide a list of impaired water bodies that may have a significant OWTS discharge component. The tables provide a schedule for the Regional Water Boards to adopt TMDLs. Since the OWTS Policy was adopted, new information has been collected and the Regional Water Boards have requested changes to the tables.

The State Water Board will accept both written and oral comments on the proposed conditional waiver renewal and TMDL list amendment. Written comments must be received by **12:00 noon** on **April 6, 2018**. Comments may be submitted electronically (e-mail), by facsimile, U.S. Mail, or courier as described below. Oral comments will be accepted at the April 17, 2018 hearing.
